

**THE B.Y.O. BRANDY SWEEPSTAKES  
OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.**

1. **Sweepstakes Period:** The B.Y.O. BRANDY Sweepstakes (the “**Sweepstakes**”) begins at 10:00 a.m. Eastern Time (“ET”) on June 1, 2026 and ends at 11:59 p.m. ET on August 31, 2026 (the “**Sweepstakes Period**”).
2. **How To Enter:** During the Sweepstakes Period, you may enter the Sweepstakes by visiting [/stellarosa.com/byo-brandy](https://stellarosa.com/byo-brandy) (the “**Site**”) or by visiting a participating retailer and scanning the Quick Response Code (“QR Code”) displayed on in-stores and completing the online entry form as prompted to receive one (1) entry (“**Entry**”) into the random drawing.
